

CLIPPERS "TRIVIA" OFFICIAL RULES & REGULATIONS – RULES SUBJECT TO CHANGE

**No purchase necessary. Contest void where prohibited.
Must be at least 18 years old to win contest prizes.**

1. Trivia Contest: During the 2011-12 NBA regular season, the Los Angeles Clippers Basketball Organization dba the Los Angeles Clippers (the “Clippers”), will conduct “Clippers Trivia” contests (individually a “Weekly/Monthly Contest” and collectively the “Weekly/Monthly Contests”) as more particularly described in these Official Rules. There will be one winner for each Weekly and Monthly Contest of the Los Angeles Clippers regular season.

A. Weekly Contests – during the 2011-12 NBA regular season, the Clippers will conduct Weekly Contests, as follows:

- 1st weekly contest: Start – 12:00AM February 7, 2012 | End – 11:59PM February 12, 2012
- 2nd weekly contest: Start – 12:00AM February 13, 2012 | End – 11:59PM February 19, 2012
- 3rd weekly contest: Start – 12:00AM February 20, 2012 | End – 11:59PM February 26, 2012
- 4th weekly contest: Start – 12:00AM February 27, 2012 | End – 11:59PM March 4, 2012
- 5th weekly contest: Start – 12:00AM March 5, 2012 | End – 11:59PM March 11, 2012
- 6th weekly contest: Start – 12:00AM March 12, 2012 | End – 11:59PM March 18, 2012
- 7th weekly contest: Start – 12:00AM March 19, 2012 | End – 11:59PM March 25, 2012
- 8th weekly contest: Start – 12:00AM March 26, 2012 | End – 11:59PM April 1, 2012
- 9th weekly contest: Start – 12:00AM April 2, 2012 | End – 11:59PM April 8, 2012
- 10th weekly contest: Start – 12:00AM April 9, 2012 | End – 11:59PM April 15, 2012
- 11th weekly contest: Start – 12:00AM April 16, 2012 | End – 11:59PM April 22, 2012
- 12th weekly contest: Start – 12:00AM April 23, 2012 | End – 11:59PM April 29, 2012

B. Each Weekly Contest will be conducted as follows:

- 1st monthly contest: 12:00AM February 6, 2012 to 11:59PM February 29, 2012
- 2nd monthly contest: 12:00AM March 1, 2012 to 11:59PM March 31, 2012
- 3rd monthly contest: 12:00AM April 1, 2012 to 11:59PM April 29, 2012

A. Season Contests – during the 2011-2012 NBA season, Clippers will conduct a season contests, as follows:

Season contest: 12:00AM February 6, 2012 to 11:59PM April 29, 2012

(i) All Eligible Participants (as defined below) possessing a Portal Account can utilize their Portal Account to answer Clippers trivia questions.

(ii) In order to qualify as a valid answer, a correct trivia answer must be produced from a Portal Account any time commencing with the beginning of the first monthly contest until the last weekly contest (“Valid Entry”).

(iii) Each week, the winner of the Contest will be the person who aggregates the most “points” during that given week of the 2011-2012 NBA regular season for all Los Angeles Clippers games. One (1) point will be awarded to participants that correctly answer each trivia question. For example, if a participant provides a correct answer to a given trivia question they receive one (1) point. At the end of each Weekly Contest, all of the points will be counted, and the person who scored the most points (i.e., most correct predictions) during the given month will be announced the winner. In the event of a Weekly Contest tie, a random drawing from among all participants who scored the highest number of points will be held to determine the winner of the Weekly Contest. Each Weekly Contest winner (either the one person with the highest number of aggregate points for the particular month or the

winner of the random drawing) will win the prize designated for the Contest (the “Prize”). Only one prize will be awarded each month to the Weekly Contest winner.

(iv) Each Weekly Contest is independent, and participants need not compete in one Weekly Contest to be eligible to compete in another Weekly Contest.

B. Monthly Contests – during the 2011-12 NBA regular season, the Clippers will conduct Monthly Contests, as follows:

- 1st monthly contest: 12:00AM February 6, 2012 to 11:59PM February 29, 2012
- 2nd monthly contest: 12:00AM March 1, 2012 to 11:59PM March 31, 2012
- 3rd monthly contest: 12:00AM April 1, 2012 to 11:59PM April 29, 2012

B. Each Monthly Contest will be conducted as follows:

(i) All Eligible Participants (as defined below) possessing a Portal Account can utilize their Portal Account to answer Clippers trivia questions.

(ii) In order to qualify as a valid answer, a correct trivia answer must be produced from a Portal Account any time commencing with the beginning of the first monthly contest until the last Monthly contest (“Valid Entry”).

(iii) Each week, the winner of the Contest will be the person who aggregates the most “points” during that given week of the 2011-2012 NBA regular season for all Los Angeles Clippers games. One (1) point will be awarded to participants that correctly answer each trivia question. For example, if a participant provides a correct answer to a given trivia question they receive one (1) point. At the end of each Monthly Contest, all of the points will be counted, and the person who scored the most points (i.e., most correct predictions) during the given month will be announced the winner. In the event of a Monthly Contest tie, a random drawing from among all participants who scored the highest number of points will be held to determine the winner of the Monthly Contest. Each Monthly Contest winner (either the one person with the highest number of aggregate points for the particular month or the winner of the random drawing) will win the prize designated for the Contest (the “Prize”). Only one prize will be awarded each month to the Monthly Contest winner.

(iv) Each Monthly Contest is independent, and participants need not compete in one Monthly Contest to be eligible to compete in another Monthly Contest.

C. Season Contest – during the 2011-2012 NBA regular season, the Clippers will conduct a Season Contest, as follows:

- (i) the Summer Off-Season Contest will commence at 12:00 p.m. Pacific Time on **TBD** and will continue until 11:59 p.m. Pacific Time on **TBD**.

D. The Season Contest will be conducted as follows:

(i) All Eligible Participants (as defined below) possessing a Portal Account can utilize their Portal Account to answer Clippers trivia questions.

(ii) In order to qualify as a valid answer, a correct trivia answer must be produced from a Portal Account any time commencing with the beginning of the first monthly contest until the last monthly contest (“Valid Entry”).

(iii) The person who aggregates the most “points” during the 2011-2012 NBA regular season will be declared the winner. One (1) point will be awarded to participants that correctly answer each trivia question. For example, if a participant provides a correct answer to a given trivia question they receive one (1) point. At the end of the Season Contest, all of the points will be counted, and

the person who scored the most points (i.e., most correct predictions) during the season will be announced the winner. In the event of a Season Contest tie, a random drawing from among all participants who scored the highest number of points will be held to determine the winner of the Season Contest. The Season Contest winner (either the one person with the highest number of aggregate points for the particular month or the winner of the random drawing) will win the prize designated for the Contest (the "Prize"). Only one prize will be awarded to the Season Contest winner.

2. **To Enter:**

A. The Contest is open only to residents of Los Angeles, Orange, Kern, Riverside, San Bernardino, and Ventura Counties who are eighteen (18) years of age or older at the time of entry. Employees and immediate family members (spouse, parents, siblings and children) of the Clippers, the National Basketball Association ("NBA") and its Member Teams, NBA Properties, Inc., their respective advertising and promotion agencies, web masters/suppliers and each of their respective parents, subsidiaries, affiliates, directors, officers, owners, partners, members, managers, employees and agents and those residing in the households of such individuals are ineligible to participate or win.

B. Void where prohibited by law.

C. Only one trivia answer per Portal Account. In the event of multiple entries from a Portal Account, only the first trivia answer received will be considered and any remaining answers will be void.

D. This Sweepstakes may only be entered by the Internet through my.Clippers.com during the Contest period (from 12:00 AM PT on **February 6, 2012** until 11:59 p.m. Pacific Time on **April 29, 2012**). To enter, go to my.clippers.com (the "Website") and follow the instructions to register and obtain a valid portal account ("Portal Account"). You must register by entering your true and correct information on the registration page (completing all required fields, including first and last name, email address, etc.) and clicking "Submit". Registration form must contain all required fields in order to obtain a Portal Account and to use such Portal Account to enter any Weekly/Monthly Contest.

E. Neither the Clippers nor any other person or entity connected with the Sweepstakes shall be responsible for any losses, damages or consequences any person may suffer due to careless or unauthorized use of a Portal Account.

F. Only one Portal Account and password may be used by any participant for a Valid Entry into any Weekly/Monthly Contest, and there is a limit of one Portal Account per participant and email address. Should any participant attempt to use more than one password or establish more than one Portal Account, that participant may be disqualified from participating in all Weekly/Monthly Contests. For purposes of these Official Rules, all times and dates are Pacific Time. It is each person's sole responsibility to update and maintain current and accurate information on his/her Portal Account. Internet access and usage charges applicable to a participant's account, including local, long distance, 800/888 access charges and/or any usage charges applicable under participant's Internet pricing plan and any applicable taxes, if any, will be the sole responsibility of the participant.

3. **Prize Notification:** Each Weekly/Monthly Contest winner will be notified by email within 48 hours after determination of the winner. Prior to being awarded any prize, the winner will be required to show proof of age and complete, sign and return a prize affidavit, release and license agreement, as

well as any other documents required by the Clippers, in its sole discretion, to claim the prize. If all required documents are not signed and delivered prior to the time of awarding of a prize, it will result in a forfeiture of the prize and the prize may be awarded to an alternate winner selected by the Clippers by a method determined by the Clippers, in its sole discretion.

4. **Prize Restrictions:** All prizes are non-transferable, and must be accepted as awarded, with no substitutions of any kind, whether in cash or otherwise, except at the Clippers’ sole discretion. The Clippers reserve the right to substitute a prize, or any portion thereof, with a prize of equal or greater value, as determined by the Clippers in its sole discretion, if a prize cannot be awarded as described herein for any reason. Each winner is responsible for any and all federal, state and local taxes, including income taxes, if any, imposed as a result of or in connection with winning, awarding or use of a prize.

Odds of winning a prize in one of the Weekly/Monthly Contests depend upon the number of eligible entries received that correctly answer the trivia questions during the specific month of Weekly/Monthly Contest that score the highest number of “points”, as described above in these Official Rules.

6. **Additional Terms:** By participating, entrants agree (a) to abide by these Official Rules, and the decisions of the Clippers regarding eligibility, selection of winners, determination of prizes or alternate prizes, and any other elements of this contest, which shall be made by the Clippers and which decisions will be final and binding; and (b) to release, discharge and hold harmless each of the Clippers, the NBA, all of its Member Teams, NBA Properties, Inc., their respective parent entities, subsidiaries or affiliates, as well as each of their respective directors, officers, owners, members, partners, employees and agents (“Released Parties”) from all liability, claims, damages and causes of action (however named or described) with respect to or arising out of any losses or injuries to the person, including death, or property, or both, of entrants which may result, be sustained, or be received by entrants, as a result of either (i) entrants’ participation in this contest, or (ii) the receipt, use or misuse of any prize. Clippers reserve the right to amend or terminate any or all of the Weekly/Monthly Contests if any factor interferes with their proper conduct as contemplated by these Official Rules. The Released Parties shall not be liable to any prize winner or any other person for failure to supply any prize, or any part thereof, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist acts, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, or any other cause beyond Clippers sole control. In consideration for being awarded a prize, each prize winner hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the use of such winner’s name and/or likeness in any and all advertising, promotions and other publicity conducted by the Clippers, the NBA, its Member Teams, NBA Enterprises, and each of their respective parent entities, subsidiaries, affiliates, except where such use is prohibited.
7. **Improper Conduct:** The Clippers, in its sole discretion, may disqualify any participant at any time, from participation in any or all portions of this Contest and refuse to award any prize(s), if participant, in Clippers’ sole discretion and determination, engages in any conduct the Clippers or its Website administrator deems to be improper, unfair or otherwise adverse to the operation of the contest or any of the Contests, or detrimental to other participants or entrants of the Contest. Such improper conduct, includes, but is not limited to falsifying personal information required during registration or prize claim, violating any term or condition stated herein, participating through methods such as automated computer scripts or any other programming techniques, allowing others to use entrant’s personal information or account for the purpose of participation, or intentionally trying to defraud, reverse engineer, disassemble or otherwise tamper with the computer programs in connection with this Contest or any of the Contests, or engages in behavior at any point that is disruptive, unlawful, or may or does endanger, or cause damage or injury to, person(s), property or the reputation of the Clippers, the NBA, its Member Teams, NBA Properties, Inc., or any of their parent entities, subsidiaries or affiliates, or otherwise violates the policies of the Clippers, or does not follow the directions of the Clippers or these Official Rules. Entrants agree that the Clippers may void any part of any prize(s) that entrant may have won and/or require the return of any part of a prize(s), or its value, that entrant may have won as a result of such improper conduct. Entrant further acknowledges that any forfeiture of any prize(s) and/or return of any prize(s) shall in no way prevent the Clippers from pursuing other avenues of recourse such as criminal or civil proceedings in connection with such conduct.
8. **Limitations Of Liability:** Released Parties are not responsible for lost, late, misdirected, incomplete, separated, or non-delivered registrations, entries, or for interrupted or unavailable satellite, network, server, Internet Service Provider (ISP), Website, telephone or other connections availability or accessibility, or miscommunications, or failed computer, satellite, telephone or cable transmissions, or lines, or technical failure or jumbled, corrupted, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures, or technical errors or difficulties, or other errors of any kind whether human, mechanical, electronic or network or the incorrect or inaccurate capture of registration, any entries, email or other information or the failure to capture, store, or loss of, any such or similar information. Any use of robotic, automatic, macro, programmed, third party or like participation methods will void all such registrations, entries and any other participation information generated or submitted by such methods, and disqualify any participant using any such methods.

Released Parties are not responsible for injury or damage to participants' or to any other person's computer related to or resulting from participating in this Contest or any of the Contests or downloading or printing materials of any kind from this Contest, or use of this Website or any other website. Should any portion of the Contest or any of the Contests, in the Clippers' sole opinion, be compromised by virus, worms, bugs, non-authorized human intervention, technical failures or other causes which, in the sole opinion of the Clippers, corrupt or impair the administration, security, fairness or proper conduct, or proper play of the Contest or any of the Contests, the Clippers reserve the right in its sole discretion to suspend, modify or terminate the Contest or any or all of the Contests, and/or continue it in a manner deemed fair and appropriate by the Clippers, and award prizes, if possible as solely determined by the Clippers, from participation materials received prior to the action taken and/or after its correction. The Clippers reserve the right, in its sole discretion, to disqualify any individual that tampers or attempts to tamper with the entry process or the operation of the Contest or any of the Contests or the Website or any website; violates these Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.

Released Parties are not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in this Contest or any of the Contests, and assume no responsibility for any error, interruption, deletion, defect, delay in operation, or transmission, communications line failure, theft or destruction, or unauthorized use to this web site.
